

Call for application to Camplus residences

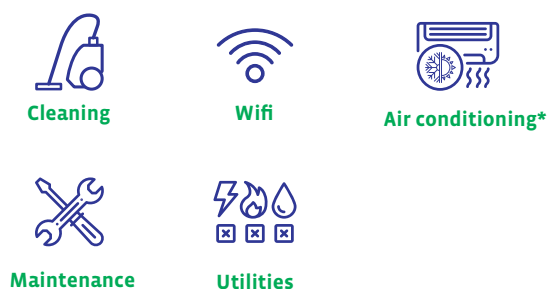

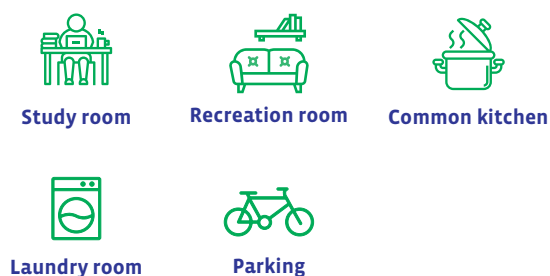
1. SPACES AND SERVICES

SPACES

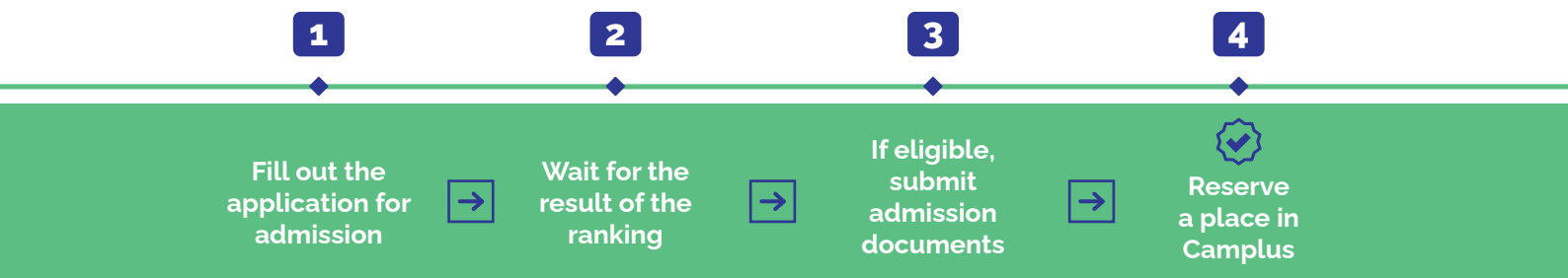

3. ADMISSION PROCESS



3.1 ADMISSION REQUIREMENTS

The candidates fulfilling the following requirements may proceed with the admission process:

- Students enrolled in any university-level school;
- Students who have not been convicted for any criminal offence and have no ongoing criminal procedures;
- Students not suffering from pathologies incompatible with community life.

3.2 APPLICATION FOR ADMISSION

Application for admission to the competition is made by filling out the appropriate *online form* on the website at the following [link](#).

Once the application is completed, the student must wait for the outcome of the ranking list.

3.3 RANKING

The *accommodation places* offered by Camplus are divided as follows:

- **60% allocated to Italian students on the basis of merit;**
- **20% allocated to Italian students with an I.S.E.E. form (Equivalent Financial Situation Index) not exceeding 20,000 euros;**
- **20% allocated to international students.**

It is specified that, in the event that in one of the categories listed above, not all of the places available are assigned, the remaining places may be allocated in the others.

3.3.1 The outcome of the ranking will be communicated directly to individual participants by Camplus staff via email or telephone according to the dates written in the schedule below.

Applications received after February 28th, 2023 will be evaluated only in the event that there are still available places to be booked.

3.3.2 The ranking, valid until to 31th August 2023, is unique and each percentage of beds allocated to individual categories will be distributed according to different criteria.

For those applying for admission as international students, equal to 20 percent of the total available seats, they will proceed in order of age, starting with the candidate with the youngest registry age.

3.4 ACCOMMODATION RESERVATION

The eligible student, will be contacted by Camplus staff to finalize the reservation of the accommodation place.

It is specified that, the assignment will be made after verifying the truthfulness of the documentation submitted during the admission.

All eligible students who, from the announcement of the outcome, will not be able to accept the place, can arrange with Camplus staff different deadlines for acceptance taking into consideration the availability of places at the Camplus residences.

4. ASCERTAINMENT OF THE TRUTH OF THE STATEMENTS

The declarant shall be responsible for the declarations made and shall forfeit the benefits obtained if it appears that the content of the declarations is not true. False statements are punished according to the Penal Code and special laws on the subject (art. 75 and 76 D.P.R. 28 December 2000, n. 445). Camplus, in turn, will carry out a sample check on the declarations produced by the means at its disposal, reserving the right, where necessary, to request additional documentation."
